MEMORANDUM OF ASSOCIATION.

I. NAME : The Name of the Society shall be 'SEVA MANDIR'.

II. OBJECTS:

1. To work for the promotion of educational, economic social, cultural and scientific advancement of rural population with a view to enable them to live an enlightened, happy and useful life;
2. To establish educational institutions, libraries, and training institutions for coaching-up village workers for the diffusion of useful knowledge amongst rural population;
3. To prepare, publish and deal in pamphlets and books and to the News-papers and to own printing presses;
4. To organise propaganda batches for the instruction of rural masses in social, cultural, economic and political topics;
5. To organise and establish sevadals and gymnasiums;
6. To organise encourage, support and establish home and cottage industries centres;
7. To employ, maintain and dismiss sevaks and other members of the establishment both paid and honorary to provide for their facilities and maintenance and to establish provident and insurance funds for them;
8. To co-operate with institutions having like-objects to aid or receive from them financial help such as subscriptions, donations and grants and to frame from time to time rules and regulations for the fulfilment of the objects of the Seva Mandir.
9. To undertake and carry out any other steps calculated to promote the above objects;
10. To make over all assets and liabilities to the all India Village Industries Association, Wardha, in the event of the Seva Mandir not being able to function.
11. To submit for arbitration to the President, AIVIA, Wardha, or arbitrators appointed by him any disputes or difficulties which may arise in the course of discharging the duties in accordance with this Memorandum and Rules and Regulations.

SCC RULES AND REGULATIONS OF SEVA MANDIR.

1. **CENTRAL OFFICE :** The Central Office of the Seva Mandir shall be at Hindupur.
2. **MEMBERSHIP: TRUSTEES:** The following Trustees shall be members of the Seva Mandir as long as they continue to be Trustees.
 1. Sri KALLUR SUBBA RAO, MLA, KALLUR, Hindupur Taluk.
 2. Sri K.S.RAGHAVACHAR, BA,LLB, Advocate and Public Prosecutor, Kamala Nagar, Anantapur.
 3. Sri M.GOVINDA REDDY, MA, B.T., LLB., Secretary, Seva Mandir, Hindupur.
 4. Sri M.N. ASWARTHANARAYANAIAH, Merchant, Hindupur.
 5. Sri MARI CHONDAPPA, Partner, Someshwar & Co., Seva Mandir, Hindupur.

Persons co-opted as Trustees shall also be members during the time they remain Trustees.

Every adult person aged 18 and above can enrol himself as a member of Seva Mandir on signifying his assent to the Memorandum of Association and to the Rules and Regulations and on payment of the prescribed fee.

3. There shall be the following classes of membership:
 1. **LIFE MEMBERS:** Every person who pays Rs. 1,000/- (One Thousand) as membership fee is entitled to be enrolled as a member for life.
 2. **DISTINGUISHED MEMBERS:** Every person who pays membership fee of Rs. 500/- (Five Hundreds) shall be entitled to be enrolled as a Distinguished Member;
 3. **ORDINARY MEMBERS:** Every person who pays a membership fee of Rs. 100/- (One Hundred) per annum shall be entitled to be enrolled as an Ordinary Member.
4. **MEETINGS:** There shall be a General Body Meeting of all members in June or July of every year to consider audited accounts and report of work done during the previous year, to frame budget and programme of work for the current year and to elect a Managing Committee for the current year.
Quorum for the General Body meeting shall be ten.
5. **MANAGING COMMITTEE:** There shall be a Managing Committee of 15 (Fifteen) members of whom the Trustees shall be members of the Managing Committee ex-officio.

And the other ten members be elected by the General Body.

6. The Managing Committee as per Memorandum of Association shall be the Managing Committee until the first General Body Meeting.
 7. The Trustees and members elected in the annual General Body meeting shall meet and elect from among themselves officebearers for the committee.
 8. The following shall be the Office Bearers:
 1. President. Only a Trustee shall be elected as President.
 2. A Treasurer.
 3. Two Secretaries.
 9. Quorum for a meeting of the Managing Committee shall be five.
 10. Powers and Duties of the Managing Committee:
 1. All properties of the Seva Mandir shall vest in the Managing Committee;
 2. The Managing Committee shall have power to own and maintain, buy or sell, lend or lease, use or otherwise dispose of, subject to the rules and regulations, all properties belonging to the Mandir and to raise and spend funds and monies.
 3. The Managing Committee shall meet at least once in every two months when they shall review the work and accounts upto the time of that meeting and approve the same;
 4. The Managing Committee shall prepare a list of members at the end of April of every year and maintain such a list in the Central Office, and such list shall be filed with the Asst. Registrar each year;
 5. Notice of a General Body Meeting shall be given at least 14 days prior to the date of such meeting and shall be sent for publication to at least 2 of the local news papers;
 6. The President of the Managing Committee shall preside over the General Body Meeting and in his absence any member of the Managing Committee may be elected to preside. In cases of equality of vote the President shall have the casting or second vote.
 7. Decisions shall be taken in the General Body Meeting and in the Managing Committee meetings on majority vote.
 8. Three members from among the staff whether paid or honorary shall be invited for every managing committee meeting, but such

members shall have no vote.

9. One or two of the office bearers may be empowered by the managing Committee to employ, control or dismiss members of the staff, to execute and atleast documents on behalf of the Seva Mandir.
10. The Society may sue and be sued in the name of the Secretary.
11. Provisions of Section 12 of Act XXI of 1860 shall apply to this Society, in case of alteration, extension, or abridgement of the objects for which the Society has been established.
